- Participants may register the day of the race at Middlefork Reservoir beginning at 7:00 a.m.

Fun Run:

- Fun Run is free for youth. Registration is not required.

Course:

The course begins by the playground at Middlefork Reservoir in Richmond, Indiana. It connects to a loop in Oak Park neighborhood and then returns to the reservoir. The roads will be blocked for the runners. The 5K course is measured but not certified. Fun Run is a 1 mile out-and-back measured from start of race.

Schedule of Events:

- 7:00 a.m. Packet pick-up and registration
- 8:00 a.m. 5K run and walk begins
- Fun Run for youth (1 mile) immediately following the race

Awards:

- All entries will be eligible for a door prize.
- Trophies will be awarded to the top three overall female and male finishers and the top three female and male finishers in each age division.
- Divisions: Male/Female 12 & under, 13-15, 16-18, 19-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, and 70 & over.
